Feb. 22 to Feb. 27, 2015



**APPLICATION INSTRUCTIONS & TRIP NOTES**

- **Sign-up:** Each individual must fill out a separate application. Each individual must be a current member of the GSOC, or a current member of another Crescent Ski Council club to participate in this trip. Copper has a good assortment of slopes for skiers of all skill levels. **Please include your cell phone # and an email address** to assist us with communications both before & during the trip.
- **Sign-up #:** The sign-up number is assigned to you based on when you submit your application and deposit. All participants of the 2014 Copper trip (including those from the 2014 trip who canceled their 2014 trip for family or medical reasons) will maintain their number (or improve it) provided they submit their application & deposit by May 31, 2014. Beginning June 1, 2014, the numbers will be assigned in chronological order. The lower the sign-up number, the more priorities you have in choosing roommates, bedrooms, bed, etc. This system is in place mainly to prevent disagreements regarding accommodations.
- **Trip Price:** \$665 (Land Only). Make all checks payable to GSOC. The price includes bus transfers to/from Denver airport, lodging for 5 nights, skiing for 4 days, and 3 parties with food & drinks. We have 15 condos reserved which will accommodate 60 people.
- **Air fares are not included in the price:** When making your individual flight arrangements (presuming you are planning to ride the group bus), please adhere to following guidelines: – **schedule your arrival in Denver no later than 12:00 PM (noon) on Feb. 22** & **schedule your departure from Denver no earlier than 12:00 PM (noon) on Feb. 27.** Group airfare may become available at a later time.
- **Roommate & Lodging Requests:** It is vital that you provide specific and complete information regarding your requests. Every effort will be made to meet individual requests, but please remember that we cannot guarantee complete satisfaction in every case. If you request a full condo of folks, please list everyone on each application after coordinating arrangements with everyone involved. If requesting a condo of more than 4 people, a lodging discount may apply only if all other condos rented are fully utilized. Any person who requests a private bedroom will be required to pay two (2) lodging fees at time of application. The extra lodging fee can only be refunded later if the club is able to sell that reserved space and trip is completely sold out.
- **Emergency Contact Information:** Please list a person's name and phone # (who isn't on the trip) that you want the trip leader to contact on your behalf in the event of an emergency. We also request that you complete a "Medical Information Form" listing any information which would aid medical personnel treating you while you are unable to communicate for yourself. Keep this form in a sealed envelope and available to your condo mates; it is only to be opened in an emergency situation.
- **Additional helpful notes:**
  1. **If you purchase a season lift pass that is valid at Copper Mountain for 2015, your trip price can be reduced by the cost of lift ticket included in the club's price. Just let us know.**
